ORDINANCE NO. 96-3

AN ORDINANCE REGULATING NEW CONSTRUCTION IN THE VILLAGE

Be it ordained by the President and the Board of Trustees of the Village of Buckner that the following is established:

Any new construction in the Village must be at least six (6) feet from the property line for safety purposes, namely fire hazards.

PASSED BY the Board of Trustees of the Village this 1st day of July, 1996.

FRANKLIN COUNTY BUILDING PERMIT INFORMATION

Building Permits are required for:

- Any property located within the city limits of a city, town or village that does not have any type of zoning or city ordinances (ex. Village of Orient, Mulkeytown, etc.)
- Any permanent structure erected on the property
- Any additions to an existing structure
- Any Mobile Home, Manufactured Home
- Any decks and/or porches if they are permanently affixed to real estate

Permits are available from the Supervisor of Assessments Office and require a \$50 fee payable to the Franklin County Supervisor of Assessments

All permits are to be approved by the County Engineer

Each structure must have a separate building permit

Cook Portable buildings, Portable Carports or any structure that is portable and smaller than 12 x 14 do not require a permit
