

ORDINANCE NO. 22-05-01

AN AMENDMENT TO ORDINANCE NO. 98-27
A NOISE AND NUISANCES ORDINANCE

BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF BUCKNER, FRANKLIN COUNTY, ILLINOIS, A MUNICIPAL CORPORATION, THAT THE SECTION ENTITLED PENALTY BE AMENDED AS FOLLOWS:

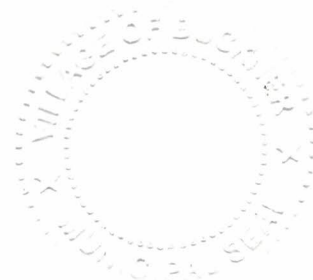
FINES AND PENALTIES

First offense—any person violating any provisions any provision of this Ordinance shall upon conviction be issued a written warning for the first violation. Violation will be recorded at the Village Hall.


Second offense—a fine of \$75.00 will be issued.

Third offense—Franklin County Sheriff's Office will be notified.

- I. All other portions of Ordinance NO.98-27 (A Noise An Nuisances Ordinance) shall remain unaffected by this Ordinance.
- II. If any portion of this Odinance shall be adjudged or declared by any court of competent jurisdiction to be unconstitutional or invalid, such judgment shall not affect the validity of the remaining portions of the Village Ordinance, and it is expressly declared that every other portion of the Village Ordinance not so adjudged or declared invalid is valid.
- III. This Odinance shall be in full force and effect after its passage, approval and publication as required by law.

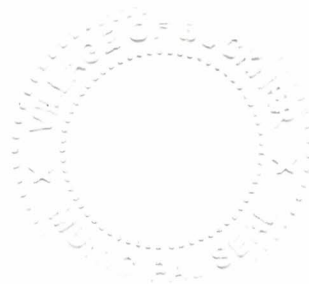

ORDINANCE NO. 98-27

A NOISE AND NUISANCES ORDINANCE

Be it ordained by the President and the Board of Trustees of the Village of Buckner that the following is established:

(A) It shall be unlawful for any person to make, continue, permit or cause to be made, continued or permitted any excessive, unnecessary loud noise or any noise which either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others within the city limits.

(B) *Noises prohibited, unnecessary noise standard.* The following acts, among others, are declared to be loud, disturbing and unnecessary noises in violation of this section, but the enumeration shall not be deemed to be exclusive, namely:

(1) *Radios, phonographs and the like.* The using, operating or permitting to be played, used or operated any radio or television receiving set, musical instrument, phonograph or other machine or device for the producing or reproducing of sound in such manner as to disturb the peace, quiet and comfort of the neighboring inhabitants or at any time with louder volume than is necessary for the convenient hearing for the person or persons who are in the room, vehicle or chamber in which such machine or device is operated and who are voluntary listeners thereto. The operation of any such set, instrument, phonograph, machine or device between the hours of 11:00 p.m. and 7:00 a.m. in such a manner as to be plainly audible at a distance of 50 feet from the building, structure or vehicle in which it is located shall be prima facie evidence of a violation of this section unless a special use permit is issued by the Village.

(2) *Animals and birds.* The keeping of any animal or bird which by causing frequent or long continued barking or other noise shall disturb the comfort or repose of any person in the vicinity. (See Penalty)

PENALTY.

Any person violating any provision of this Ordinance shall upon conviction be issued a written warning for the first violation and a fine of \$300.00 for each offence thereafter.




