WHEREAS, the Board of Trustees of the Village of Buckner will consider to reimburse the costs, up to \$500 of a dumpster to owners of vacant dilapidated properties.

WHEREAS, the property owner must submit to the Board of Trustees an application for reimbursement and the receipt for the dumpster.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE VILLAGE OF BUCKNER DOES HEREBY ACCEPT, ORDER AND DETERMINE AS FOLLOWS:

Section 1. The reimbursement application must be submitted to the Board of Trustees of the Village of Buckner within 30 days before the rental of the dumpster.


Section 2. The maximum amount of reimbursement is up to \$500.

Section 3. The property must be completely cleaned up within 60 days before the cost is reimbursed.



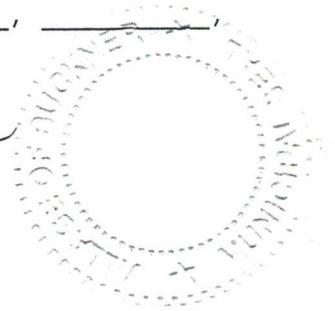
