An ordinance for licensing permits for  
ATV/UTV within Buckner Village Limits

It is hereby ORDAINED by the Mayor and the City Council of the Village of Buckner, Franklin County, Illinois, a Municipal Corporation as follows:

The use of ATV/UTV's will be allowed by permit upon completing an inspection and fees paid if the following criteria are met.

Vehicle must be equipped with the following:

Head lights	_____	Windshield	_____
Taillights	_____	Muffler (under 96 DB)	_____
Brake Lights	_____	Seatbelts	_____
Rearview Mirror	_____	Reflectors (Front & Back)	_____

Insurance must be carried for ATV/UTV and must be shown upon request. ATV/UTV's are not allowed on Highways, and are not to exceed 20 mph. No riding on or in rear of ATV/UTV unless vehicle is equipped with seats to do so. No Dirt bikes, 4-Wheelers or other altered vehicles are allowed. Drivers must be 16 years of age and have a valid Illinois driver's license. No underage passengers are permitted with a driver under the age of 18 years.
